Re: Sign Program for AutoNation Oxnard

Dear Mr. Donnelly:

The sign program approved for AutoNation Oxnard consists of approval for 1200 square feet of sign area which is the maximum allowed by City Code. In accordance with Section 34-186 (C) (2) one on-site free-standing sign shall be permitted for any one parcel having 300 lineal feet of continuous street frontage. The project has one free standing sign along the freeway frontage.

The project does not meet the requirements for a variance to be granted to permit the addition of an exterior overhead sign as the project does not meet the criteria as established in Section 34-158.1 of the City Code. This section establishes the prerequisites for granting a variance. It must be shown that the variance does not constitute a grant of special privilege. That there are special circumstances applicable to the property such as size, shape, topography, location or surroundings, that deprive the property of privileges enjoyed by other properties in the vicinity and zoning classification. Granting of the variance would not be detrimental to the public interest, safety, health or welfare and will not be detrimental to the property or improvements in the same vicinity or zone. Lastly that the granting of a variance is not contrary to the general plan. The subject property does not meet the majority of these criteria.

Section 34-186 (K) (2) would allow you to request that the Planning Commission consider approval of a new master sign program if it could meet the established requirements. However, one of the requirements is that the amount of sign area does not exceed that which would be allowed by the City Code. The sign area would need to be reduced for the other on site signs so that the additional square footage of the proposed overhead sign together with the other signs do not exceed the maximum total sign area of 1200 square feet allowed by City Code for the project.

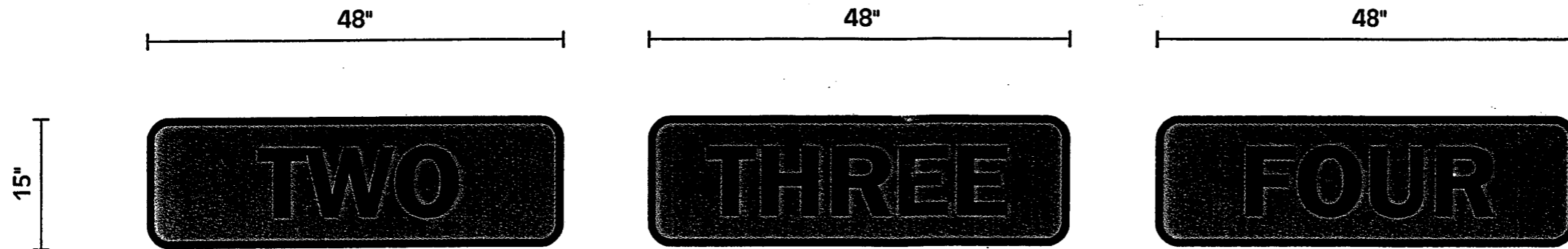
