- 2. **Requests for Information.** The City has received requests for information (RFI) on this project. The questions and City responses are below:
- Question 1: Notice Inviting Bids, Section 10 "Substitution of Securities and Retention" states "The City shall withhold five percent (2.5%) of any progress payment as retention." Please confirm the retention amount is 2.5%.
- Response: The retention amount is two point five percent (2.5%). Bidders are instructed to replace page NIB 2 provided with the Bid Package with the attached replacement page R NIB 2.
- Question 2: On Page 17 of the special provisions, it is stated "Additional fill will be placed over the existing 30" gas transmission line in two places to construct the new roadway." in the 8" gas line section. Please confirm this sentence applies to the 8" gas line.
- Response: Yes, this sentence applies to the 8" gas line. Bidders are instructed to replace page 17 provided with the Bid Package with the attached replacement page R 17.

- Question 3: Part 7 of the Bid Proposal states "The undersigned hereby certifies that all items listed below are checked, fully completed, executed, and hereby submitted with this Bid Proposal." However, the last document in the list is "An Escrow Document Cover Page and Escrow Bid Documents (required for projects with Bids over \$500,000 and due from the three (3) lowest within three (3) Business Days of bid opening date)." Please confirm that the Escrow Bid Documents are not due with the bid and shall be turned in within 3 days after bid opening. Please consider revising the Bid Proposal form accordingly.
- Response: Escrow Bid Documents are to be submitted within 3 business days after the bid opening.
- Question 4: ATTACHMENT 2: UPRR CONTRACTOR'S RIGHT OF ENTRY AGREEMENT & ATTACHMENT 3: UPRR PIPELINE CROSSING AGREEMENT/REQUIREMENTS have different insurance requirements. For example, Exhibit C of the Right of Entry Agreement lists a requirement for the Commercial General Liability of \$5million per occurrence and an aggregate limit of not less than \$10million. Exhibit C of Attachment 3 lists \$2million per occurrence and an aggregate limit of not less than \$4 million. Please confirm that a single policy with the limits specified in Exhibit C of Attachment 2 is acceptable for both the UPRR Right of Entry Agreement (Attachment 2) and the UPRR Pipeline Crossing Agreement (Attachment 3).
- Response: Contractor is to comply with the UPRR's insurance requirements as stated.

Please confirm that traffic control may also be performed by the "A" licensed Prime Contractor if they elect to self-perform this work.
- The contract contained in the Bid Package is a sample and subject to change. Response: The City will accept a C-31 or A license for the traffic control work in Section 4B.
- Question 7: Section 13-2.0 Please confirm that the City of Oxnard will still be the Legally Responsible Party (LRP) for the separate NPDES Permit to be obtained by the Contractor.
- Yes, the City of Oxnard will be the LRP for the NPDES Permit. Response:

Contract Documents unless other forms meet all of the City's requirements including that the Bond limit be automatically increased if the Contract amount is increased after execution of the Contract, and the City Attorney at his or her discretion approves the Surety's form. **7.** <u>California State Prevailing Wage</u>. This Project is a "public work" subject to the requirements of Division 2, Part 7, Chapter 1 of the Labor Code and Title 8, Division 1, Chapter 8 of the California Code of Regulations ("CCR"). The Contractor and all Subcontractors shall pay wages in accordance with the determination of the Director of the DIR. Copies of these rates are on file with the Project Coordinator at City Hall and will be made available to any interested party on request. 8. <u>DIR Registration; Compliance Monitoring</u>. **11.** <u>Award</u>. The City reserves the right to reject any or all bids or to waive any irregularities or informalities in any bids or in the bidding process.

**12.** <u>Liquidated Damages</u>. Contractor must complete all Work within seven hundred eighty (780) Working Days of the City's Notice to Proceed. There will be a \$16,000 assessment for each Calendar Day that Work remains incomplete beyond the Project completion deadline.

## **Utility Requirements and Coordination**

#### SCE Transmission poles

Upon relocation of the existing overhead 66kV transmission line, northerly of the UPRR from the east side of existing Rice Ave.to the east side of the realigned Rice Avenue, the contractor shall protect all steel and wooden poles by furnishing and placing concrete K-rails on all four sides of each pole with a min separation of 5' of separation from the face of the K-rail to the steel pole. Contractor shall also maintain a 20-foot vertical clearance between all construction equipment and the overhead 66kV transmission cables during construction of the roadway embankment. Payment for such protection in considered incidental and shall not be a separate bid item but included in the various bid items.

## 30" Transmission Gas line

Additional fill will be placed over the existing 30" gas transmission line in two places to construct the new roadway. From Sta 100+72 to Sta 103+60 there will be an additional fill of 1.5'. From Sta 131+65 to 138+15 there will be an additional fill of 3.5' to 5.5'. Contractor shall consult with SoCalGas are the start of construction to confirm the requirements below for protecting the 30" transmission line in place.

SoCalGas has determined that a minimum of 42 inches of compacted soil will be required for the vehicle to cross over the pipeline and that compaction or other equipment with vibratory features shall not to be used over the pipeline. SoCalGas has advised that Per Federal Regulations Section 192.614, Title 49. (1) any excavation within 10' of High-Pressure gas pipe supply line is required to have SCG-employee(s) on site. In addition, there can be no mechanical digging directly or grading directly over the pipe, but only hand-digging directly over a HP line.

Arrange for SCG inspection during construction within 10' of the pipeline, by calling 811 and ask for "Standby for Transmission".

#### 8" High Pressure Distribution Gas line

Additional fill will be placed over the existing <del>30</del>" 8" gas transmission line in two places to construct the new roadway. From Sta 103+00 to 105+50 there will be an additional 2.5'. From Sta 129+80 to 138+10 there will be an additional 11' of fill. SoCalGas has determined this line does not require to be relocated, but it is to be protected in place. Contractor shall consult with SoCalGas are the start of construction to confirm the requirements below for protecting the 8" transmission line in place.
